### **RULES FOR THE INTERNATIONAL STUDENTS (BOYS/GIRLS)**

As per vide Clause no. 4.2/31 of the 31<sup>st</sup> Executive Council held on 3<sup>rd</sup> July 2021, the student shall abide by all the rules and regulations that are brought in force by the authority of Assam Rajiv Gandhi University of Cooperative Management, Sivasagar with immediate effect. The rules are as below:

1. The student shall not make any false or incorrect statement, concealed any information and/or use fraudulent means to secure their stay in the hostel.
2. The student shall not indulge in any act that is unbecoming of a student, including vandalism, staging dharna, aggression, defamation, instigation, unruly behaviour or any such act that is construed to be unlawful, illegal, and that harms the interest, name and reputation of a member of the University and its hostel or of the University as an academic body.
3. The student should not engage themselves in activities which may cause injury to them in person or property. In case, any injury is caused to due to their involvement / engagement in any manner in any activity, which is not authorized by the University/hostel or on which University and / or hostel does not have any control, then the student will be solely liable to bear its consequences.
4. If the student indulges in any fights or falls prey to any police case outside the purview of the University, the same shall be informed to the concerned authority of the University with an immediate effect. This shall be forwarded to the higher authorities and such instances may result with strict and immediate action against the student.
5. Possession of arms or any such items will be considered unauthorized and the same need to be reported to the University authority with immediate effect.
6. In the boy's hostel, no girls would be permitted to enter and the same applies for girl's hostel.
7. The student shall not make any abusive comments to the neighbors' residing near the hostel or anyone from the University or from outside. This should be applicable to his/her fellow mates too.
8. The student will have to maintain cordial relationships with all the other students either in the University campus or in the hostel. Inside the hostel, the academic environment of any of the other student should not get hampered due to some personal likings or habits of a particular student.

9. At the time of admission to the University itself, the student should give a declaration regarding his/her medical health including maternity details, if any.
10. Consumption of alcohol, drugs and any such items is strictly prohibited within the University and hostel campus.
11. The student shall be responsible enough for checking the notice board, email, messages, etc. as given by any faculty or concerned authority from the University from time to time and respond accordingly.
12. If the student wants to travel anywhere within India, necessary permission to be taken from the concerned authority of the University. If the students want to travel outside India, necessary permission and approval from the University, ICCR, or their sponsoring organization is a mandate.
13. The student will have to abide by the rules and regulations as set by the Govt. of India from time to time.
14. For the Covid pandemic situation, the curfew and lockdown norms as set by the district administration need to be followed by the student mandatorily.
15. University is not responsible for providing food/cylinder etc. to the student in their hostel. They will have to meet these necessities by their own and from the living expenses provided to them by their sponsoring organization or they will have to make these arrangements by their own.
16. The student will have to enter the hostel within 7 p.m. during normal days. If they stay outside or wants to go outside, after 7 p.m., proper permission to be taken from the concerned authority of the University.
